SUPPLEMENTARY REGULATIONS. (please read carefully)

- 1. No "Fun bikes" or non-competitive bikes will be allowed on the ground.
- 2. "NON-STOP" method of marking will be used.
- 3. Registration Card MUST be shown when signing on at the start.
- 4. Method of deciding ties:- most cleans, if still tied most 1s, most 2s, etc.
- 5. Sections will be closed by a back marker. Time will be advised at riders briefing, along with any final instructions.
- 6. All competitors must have a cut out device rigidly connected to the rider by lanyard.
- 7. Riders **NOT** competing in the Championship, can choose to ride as a Clubman on either Route A or B
- 8. **Helmet Cameras** are **not** permitted. Cameras attached to the machine are allowed, subject to permission from the clerk of the course.
- 9. Parents or Guardians of youth(s) signed on must NOT leave the ground.
- 10. Protests must be received in writing accompanied by a £50.00 protest fee.
- 11. Riders must keep to the flagged route.
- 12. I confirm that I am not currently suspended from ACU/SACU permitted competition or on the ACU/SACU Stop List as a result of incurring a concussion in jury. I shall notify the Club should I incur such a suspension or concussion injury between now and this event.
